Climate Change in the Arctic


The backdrop for this research








Figure 2: Simplified model of a socio-ecological system

SES-Resilience

“capacity of social, economic and ecosystems to cope with a hazardous event or trend or disturbance, responding or reorganising in ways that maintain their essential function, identity and structure as well as biodiversity in case of ecosystems, while also maintaining the capacity for adaptation, learning and transformation.” (IPCC 2022)

Socially: “capacity of people to learn, share and make use of their knowledge of social and ecological interactions and feedbacks, to deliberately and effectively engage in shaping adaptive or transformative social-ecological change”.

Adaptability/Adaptive Capacity: Coping with changes on an ecosystem or social level

Persistence: Continuing to exist without crossing any thresholds

Transformation: transforming certain pathways that appear to become less and less viable





Figure 2: Simplified model of a socio-ecological system
